



29/06/2019 – Kick-off meeting Skopje

All partners present except for VSA (Thailand) due to VISA/travel issues

Budget cut: the final meeting in Bulgaria was cut for a mistake, due to the fact that 2 activities (budget lines) had the same budget, thus looking like an error of double founding. So IIC tried to find a solution by cutting 2 days from every mobility and creating a new budget line for the final meeting. Another solution would be to use the travel money for the final meeting (which are founded) to finance one more person per partner for the other international trainings. But the EACEA did not approve it because they have never found themselves in such a situation.

Solution UPDATE for the Greek TC in April 2020:

- 1. To hold only the Bulgarian event and host 3 pax instead of 2 (thus losing part of the budget for the 4th pax) maybe option to transfer the 10% of the budget.
- 2. TC in Greece: we have the travel budget, but not the board and lodging. A solution could be for every organisation to contribute for the 2 pax they're sending. YouNet's Italian VETs? K.A.NE can help looking for students who can cook? <u>Accommodation and food should be covered by the partners or the participants.</u>
- 3. The TC in Greece could be held right after the event in Bulgaria. In this way, the 2 pax will travel directly from Greece to Bulgaria and save on travel budget in order to cover the other expenses of boarding and lodging.

IIC will ask EACEA to prolong the project for 3-5 months. The official end date of the project is June 2020, but IIC will ask the commission to October-November 2020.

1ST PHASE: INTERNATIONAL TRAININGS

The 2 international trainings in Vietnam and Nepal (updated, not Thailand anymore) (7-days each) will have to be implemented before Christmas time 2019 (November-December 2019)

Changes made to this phase:

- → Training in Greece was cut in order to ensure the final partners' meeting in Bulgaria.
- → Filaretos (K.A.NE) will be a co-trainer in the 2 international trainers in Vietnam and Nepal.
- → The 2nd training course will be in NEPAL (not in Thailand)

TC in Vietnam: last week of October (23rd-31st) – 2 pax per country

- Civic education and engagement
- Democracy
- Digital activism, media and freedom of expression
- Active citizenship and participation
- Advocacy and lobbying
- Conflict management and resolution

TC in Nepal: 9 days between 7th-17th January 2020 - 2 pax per country

- Strategic planning
- Community sustainable development and growth including SDGs
- Developing and implementation of campaigns and local initiatives
- Conflict management and resolution

2ND PHASE: JOB SHADOWING

5 job-shadower from European partners will go to Asia, and 5 job-shadower from Asian partners will travel to Europe (1 representative per partner) for 3 WEEKS.

Thus, each partner will send 1 participant for 3 weeks and host 1 pax for 3 weeks.

Vietnam: mid-September-end of December

India: mid-September-end of February

Bulgaria: April-May

Italy: April-July

Macedonia: April-May

ASIA to EU – between April-May 2020

Vietnam→Bulgaria (originally: North Macedonia)

Thailand → Greece

India -> Croatia

Philippines → North Macedonia (originally: Bulgaria)

Nepal → Italy

Analysis of the needs of the NGOs (sending and hosting) and the participant, in order for the job shadowing mobility to be tailor-made for that specific job-shadower – programme of the mobility / selection of the dates and of the job-shadower. Deadline: 31st July

COMMON STANDARDS:

- Single room with the kitchen usage / Homestay
- WiFi in the office, and in the house whenever possible (if it's not possible, to provide a local sim with internet)
- 3 meals per day

BUDGET

European partners: limit of 1100€ for 1 job shadower

Asian partner: limit of 1008€ for 1 job shadower

Budget division: 300€ for the job shadower (food allowance) / 800€ (EU) or 708€ (Asia) for the hosting organisation for the rent, local transportation, etc.

→ Insurance is on the job shadower (only expense)

3RD PHASE E-LEARNING PLATFORM WITH 10 WEBINARS

Each partner will deliver 1 webinar and 5 participants per country will have to take part in each webinar (5 pax for 10 partner countries for a total of 50 pax for each webinar).

Shared e-platform will be on ZOOM.

Topics: chosen by the partner (see list on the project summary)

Format: 1 hour-long plus 30 minutes for the questions/doubts

4TH PHASE: NATIONAL TRAININGS (in each partner country)

Each partner will organise 3 two-day national trainings (for a total of 6 days) for their target group. Each national training will have to involve at least 20 pax. The LEAD Youth Council will be created as a result of these 3 national trainings, and it will be a satellite entity of the partner, targeting social and youth issues; the aim is for them to become independent.

BUDGET:

Europe: 15€*20pax*2days*3trainings=15€*20pax*6days=1800€

Asia: 10€*20pax*2days*3trainings=10€*20pax*6days=1200€

<u>AIM</u> of the Youth Council: to create a non-formal group of young people who will work together voluntarily in order to implement a local action, help in the national trainings and, then, ultimately motivate them to take action independently as an autonomous entity or at least function as a stimuli for them to be active citizens, democratic and participate. The name works as a symbol of youth empowerment.

The LEAD Youth Council does NOT have a budget.

5TH PHASE: LEAD YOUTH COUNCIL and LOCAL COMMUNITY ACTIONS

The LEAD Youth Council will have to organise (at least) a local action

6TH PHASE: FINAL MEETING IN BULGARIA: international lead platform

2 pax from each partner will take part in this 7-day event in Bulgaria (5 pax for IIC)
